### **General Guidelines for the Course**

- 1. The mode of classes will be offline.
- 2. Fee shall be paid in online mode only. The fee once paid shall not be refundable or transferable.
- 3. On the commencement of the course, it is mandatory for the students to attend all the classes pertaining to the course.
- 4. The total duration of the course shall be 20 hours.
- 5. The classes will be held as per the schedule.
- 6. The certificate shall be provided to the students upon successful completion of the course.
- 7. In order to support economically weaker section (EWS) and reserved category (SC/ST/OBC with NCL/PWD) students, Merit-cum-Need based scholarships are offered in the form of 50% fee waiver to 10 percent students of total batch size. This scholarship shall be given in the form of refund after completing the course and applications shall be shortlisted on the basis of a student's academic performance.(scholarship is for SRCC students Only)
